**ORDER:-**

In the reference 16<sup>th</sup> read above, orders have been issued for implementing Scheme of reimbursement as well as "Employees health scheme" up to 31-03-2018.

2. In the reference 13<sup>th</sup> and 14<sup>th</sup>, read above, Government have issued comprehensive guidelines for providing cashless and qualitative treatment to the State Government Employees, Pensioners and their dependent family members and establishment of (14) Wellness Centers for Medicines / Drugs for outpatient investigation to the State Government Employees, Pensioners, Working and Retired and their dependent family members. Though these orders were issued, the scheme has yet to commence in a full fledged manner.

3 Accordingly, Government after careful examination, hereby extend both the schemes of Reimbursement and the employees Health Scheme to be run in the same manner up to June, 2018 or till further orders, whichever is earlier.
