Based on the Hon'ble High Court orders in reference 2<sup>nd</sup> read above, Government after careful examination of the matter, hereby issue the following amendments to the G.O.1<sup>st</sup> read above:

1.	<b>Rule 4 (i) – Competent Authority for issue of transfer and posting orders:</b> District Educational Officer (DEO) of the erstwhile Revenue District for the School Assistant/ SGT and equivalent cadres. The District Educational Officer of the erstwhile Revenue District shall consult the District Educational Officers of the newly formed 31 districts.	The Regional Joint Director of School Education concerned i.e. Regional Joint Director, Warangal / Hyderabad.
2.	<b>Rule 16(1) – Appeal</b> An appeal against the orders of the District Educational Officer shall lie with the Regional Joint Director of the School Education concerned, and an appeal against the orders of the Regional Joint Director of School Education shall lie with the Commissioner and Director of School Education. Such appeal should be submitted within 10 days of the receipt of the transfer orders.	An appeal against the orders of the Regional Joint Director of School Education concerned shall lie with the Commissioner and Director of School Education. Such appeal should be submitted within 10 days of the receipt of the transfer orders.
